This factsheet outlines the zoning and rules for the Lord Howe Marine Park, as set out in the Temperate East Marine Parks Network Management Plan.

The zoning and rules for activities in marine parks of the Temperate East Network, will help to achieve a positive outcome for the environment and the Australian community, by protecting important marine habitats, features and species, while supporting use and enjoyment of these special places. It is important that users of the marine parks are familiar with the rules and zones in marine parks. This factsheet should be read in conjunction with the plan.

Managing activities in the Lord Howe Marine Park

The management plan is located on the Parks Australia website. It describes the management of the Temperate East Network, including the Lord Howe Marine Park, over the next ten years. The plan enables a range of activities and sets out which activities are allowed (without authorisation), allowable (with authorisation), or not allowed. For those activities that are allowed or allowable, the plan also provides information on the assessment and decision-making processes, the types of authorisations and how activities need to be undertaken.

About the Lord Howe Marine Park

There are eight Australian Marine Parks that make up the Temperate East Network. The Lord Howe Marine Park is one of these. The Lord Howe Marine Park has been designed to complement the management arrangements of the New South Wales marine park. The Marine Park is popular for fishing, snorkelling, diving and boating. It supports commercial fishing and tourism, which contribute to economic growth, employment and social wellbeing on Lord Howe Island.

The Lord Howe Marine Park includes habitats such as the Elizabeth and Middleton Reefs, Lord Howe seamount chain and the Tasman Front and Eddy Field. It also includes important habitat for seabirds and humpback whales and has high levels of species richness and diversity.

News-of-the-day reporting may be undertaken on terms determined by the Director from time to time, and subject to the Director being notified.
Spearfishing is not allowed.
Activity is allowable only for the protection, conservation or restoration of habitats.

Note:

- Anchoring by commercial fishing and aquaculture vessels is not is not allowed in the National Park Zone (II), except in anchoring areas determined under the EPBC Regulations.
- Fishing gear must be kept stowed and secured at all times during transit through, or while stopping and anchoring in, a zone in which fishing activities are not authorised.
- Disposal of waste from normal operations of vessels must comply with MARPOL requirements.
